This is to confirm that groundwater sampling and dust monitoring at Spring Farm (see Appendix 1 for sample locations) has been carried out with the results summarised in Tables 1 and 2 respectively below.

- Moderately alkaline falling marginally outside the nominated pH range of 4 6.50;
- Met the limit of the target depth of > 10 m.

The EMP target values were met at Monitoring Stations 1 and 3 but not at Station 2. The significant exceedance at Station 2 appears to be related to nearby earthworks associated with the rehabilitation of the site occurring at times during strong wind events.
